- a) Natural Narcotics; Marijuana, Opium.
- b) Semi-synthetic narcotics; Morphine, which is derived from Opium is processed mixed with synthetic ingredients.
- c) Synthetic narcotics; meth (amphetamine), ecstasy, cocaine, Heroin, Putau.
- 2. Types of narcotics according to law No. 35 of 2009 on narcotics is divided into 3 (three) groups, namely :
  - a) The most dangerous narcotics of this group-I consist of: marijuana, heroin, cocaine, morphine, opium.
  - b) Narcotic Group-II, it has a strong addictive power, terdiridari, pethidine, benzetidine, betamatedol.
  - c) Narcotics Group-III, has a mild addictive power, namely codeine .

In order to prevent it from being easy to get the source of drugs / drugs, which is done by applying the law expressly to drug abusers to the public and government officials. An environment that has the potential to prevent drug abuse is in the family and Community Environment. Prevention efforts in the family environment that can be done simply is :

- a) Parents need to have knowledge about drugs in order to inform children about the dangers and adverse effects of using drugs.
- b) Parents / family members do not excessively trust the child that the child does not have a problem. If you see a change in attitude in an unusual child, in order to immediately detect it.
- c) Do not hesitate to supervise and look for the causes of changes in behavior and behavior in your child.
